

ACCEPTABLE USE POLICY

You must comply with this Acceptable Use Policy when accessing the Website.

You may use the Website for lawful purposes only.

You must not use the Website:

- if your use breaches any applicable law or regulation whether local, national or international.
- if your use is unlawful or fraudulent.
- if your use harms, or could harm, minors in any way.
- to send spam materials to other people.
- to post any contributions which contain material which is defamatory, obscene, offensive, hateful, inflammatory, deceptive, is likely to harass, upset, embarrass or impersonate any person or which is sexually explicit, promotes violence or any form of discrimination on the basis of race, gender, religion, nationality, disability, sexual orientation, or age, or which infringes any third party intellectual property rights or other rights.
- to knowingly introduce or transmit viruses, trojans, worms, logic bombs or other material which is malicious or technologically harmful.
- to post content that contains unethical or unwanted commercial content designed to drive traffic to third party sites or boost the search engine rankings of third party sites.
- to seek or unlawfully provide information which is confidential to a third party, or is price-sensitive, or would place you in a conflict of interest (for example, seeking to obtain information about competitors without disclosing your interest).
- to obtain information which is then used to contact another Member in any manner which might undermine the operation of the Local Supply Chain, Work Radar, or Performance365 marketplaces.
- to impersonate other people, particularly other Members or employees or representatives of Local Supply Chain, Work Radar or Performance365
- in any manner which could reasonably be regarded as placing you in a position of conflict of interest or violate any current obligations that you have to third parties (including, but not limited to, your employer). If you become aware of any conflict caused by your use of the Website then you must cease such use immediately.

When posting content to the Website you undertake to:

- treat your fellow Members and other participants with courtesy, professionalism and respect.
- provide information which is accurate and not misleading.
- disclose any relevant conflict of interest.
- consider the likely audience for any information you post (which will depend on the manner in which you provide the information through the Website) and not improperly post or disclose confidential or sensitive information.
- treat as confidential and not disclose information which has been provided by another Member on a confidential basis or in circumstances which would reasonably lead a third party to conclude the information was intended to be treated as confidential.

In addition:

- You must not gain, or attempt to gain, unauthorised access to the Website, the server on which the Website is stored or any server, computer or database connected to the Website.
- You must not attack the Website via a denial-of-service attack or a distributed denial-of service attack or do anything that could disable or impair the Website.

If you breach any provisions of the Computer Misuse Act 1990 you may be committing a criminal offence. We will report any such breach to the relevant law enforcement authorities and we will co-operate with those authorities by disclosing your identity (if known) to them.

If you breach the terms contained in this Acceptable Use Policy, your right to use the Website will cease immediately.
